# **Nifty Bull Spread Strategy**

NIFTY (20-JULY EXPIRY) 19700 CALL	19.05	SELL 19700 CALL @ CMP	Till 20 JULY expiry

Primary trend of the Nifty is bullish as it is trading above all its important moving averages. Breadth of the market is very strong, which indicates higher probability of Nifty breaking out from the range of 19300 to 19500 levels on the upside. Therefore, we expect Nifty to trend higher in the coming week till 20 July 2023 expiry.

We therefore recommend a Bull Spread strategy in Nifty to profit from this view.

### Action to be taken

Buy Nifty 19500 Call @Rs 73.45 & Simultaneously Sell Nifty 19700 Call at Rs 19.05 (20 - July Expiry)


